A total of 1,545 students are eligible to receive Emergency Financial Aid Grants under CRRSAA.

During the second quarter of 2021, 1,545 students received Emergency Financial Aid Grants under CRRSAA.

In accordance with Department of Education guidelines, the College prioritized student financial need when determining aid amounts and used eligibility for Title IV funding as the primary factor for identifying high-need students; 940 non-Pell students each received \$370, and 605 Pell students each received \$700.


