

## CONSUMER INFORMATION

In accordance with federal regulations as set forth by the Higher Education Act of 1965 (HEA), as amended by the Higher Education Opportunity Act of 2008 (HEOA), below is a summary of consumer information that must be disclosed to all students at Lurleen B. ### FEDERAL FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

The [Family Educational Rights and Privacy Act \(FERPA\)](#) is a Federal law that protects the privacy of student education records. [FERPA General Guidance for Students](#) is a website provided by the federal government. The Act establishes the rules and regulations regarding access to and disclosure of student records. It provides for the right to inspect and review education records, the right to seek to amend those records, and the right to limit the disclosure of information from the records.

To fulfill FERPA requirements, the College has established policies regarding student records. These policies outline a student's rights regarding his/her records, where records about the student may be kept and maintained, what kinds of information are in the records, the conditions under which the student or anyone else may have access to information in the records, and what action a student can take if it is believed student's rights have been compromised. Policies on privacy of students and release of records are included in the *College Catalog and Student Handbook* pages 285– 287.

The College is also required to annually notify students of their rights under FERPA. Students are given a written copy of these rights at Orientation which is included in the Orientation materials and are provided a link to the *College Catalog and Student Handbook*. ## REFUND POLICY

Lurleen B. Wallace Community College has a [refund policy](#) that stipulates the amount of tuition and fees to be refunded to students who withdraw from classes during a term. ## NET PRICE CALCULATOR

The Net Price Calculator is intended to provide **estimated net price information** (defined as estimated cost (price) of attendance – including tuition and required fees, books and supplies, room and board (meals), and other related expenses – minus estimated grant and scholarship aid) to current and prospective students and their families based on what similar students paid in a previous year.

The estimate provided using this calculator does not represent a final determination, or actual award, of financial assistance or a final net price. It is an estimate based on price of attendance and financial aid provided to students in a previous year. Price of attendance and financial aid availability change year to year. The estimates shall not be binding on the Secretary of Education, the institution of higher education, or the State.

## **REPAYMENT POLICY (RETURN OF TITLE IV FINANCIAL AID)**

Lurleen B. Wallace Community College complies with federal regulations relative to return of tuition and other institutional charges for all Title IV recipients. The Federal Return of Title IV Funds Policy is to be used for a Title IV student who completely withdraws from all classes. The policy shall also be applied to those students who cease attendance in all classes but do not officially withdraw. The Return in Compliance with Federal Regulations is included in the *College Catalog and Student Handbook*, page 26 and the College website - [Refund Policies - Business Office](#).

The federal government mandates that students who withdraw from all classes may only keep the financial aid (federal “Title IV grant”) they have “earned” up to the time of withdrawal. Funds that were disbursed in excess of the earned amount must be returned by the College and/or the student to the federal government. ## **WITHDRAWAL PROCEDURES**

Lurleen B. Wallace Community College has a withdrawal policy which states that a student may withdraw from a course or all courses without grade penalty until fourteen (14) days prior to the first day of final exams for the fall and spring terms. For the fall and spring mini-terms, a student may withdraw from classes until seven (7) days prior to the first day of final exams. For the summer term, a student may withdraw from classes until nine (9) days prior to the first day of full-session final exams. For the summer mini-terms, a student may withdraw from classes until four (4) days prior to the first day of mini-session final exams. The final date for official withdrawal is printed in the [College Calendar](#) and published in the [Class Schedule](#). To officially withdraw, a Withdrawal form must be obtained from the Office of Student Services, completed and signed by all persons indicated on the form and returned to the Office of Student Services.

All withdrawals forms must be completed and returned to the Office of Student Services for processing before a student is officially withdrawn from a course or courses. **It is the student’s responsibility to follow these withdrawal procedures.** This policy is located in the *College Catalog and Student Handbook*, pages 53-54 and the College’s website.

Students may be administratively withdrawn from all courses for excessive absences or for other administrative reasons (such as student discipline, leading to suspension or expulsion). Withdrawal may impact a student's ability to qualify for financial aid, and may result in the need to repay financial aid already received.

The Alabama Articulation Program (called **STARS** – Statewide Articulation Reporting System) is a computerized articulation and transfer planning system designed to inform students who attend Alabama Community Colleges about degree requirements, course equivalents, and other transfer information pertaining to specific majors at each state funded four year institution. Lurleen B. Wallace Community College students planning to transfer to an Alabama public senior institution must print and retain the Articulation Guide for their major along with the transfer institution's Area V courses. The guide and Area V course listing must be submitted to the senior institution upon transfer. ## **FEDERAL STUDENT FINANCIAL AID PENALTIES FOR DRUG LAW VIOLATIONS**

Lurleen B. Wallace Community College provides a written notice in the financial aid award letter that advises the student that a conviction for any offence, during a period of enrollment for which the student is receiving Title IV funds, under any federal or state law involving the possession or sale of illegal drugs will result in the loss of eligibility for any Title IV, HEA grant, or work-study assistance.

The period of ineligibility for federal student aid funds depends on whether the conviction was for sale or possession and whether the student has previous offenses. Periods of ineligibility may

range from one year from date of conviction to an indefinite period as determined by a federal or state judge. Students must also complete a qualified drug rehabilitation program.

### **GRADUATION, TRANSFER-OUT AND RETENTION RATES**

Lurleen B. Wallace Community College maintains annual information regarding graduation, transfer-out and retention rates for first-time full-time entering freshmen. While many students enter the College with varying educational goals, the College is required to disclose information for first-time full-time entering freshmen who are certificate or degree-seeking undergraduates and have completed their programs within 150% of the normal time for graduation.
